## Terms and conditions

### Terms of membership

To be member of the association, the application must be approved by the board of directors.

Companies applying for membership must:

- Provide a KBis/official company registration or equivalent.
- Be sponsored by a member of the board of directors and two active members of the association.
- Provide a history of experience in the yachting industry of the company's officers or shareholders.
- The board of directors reserves the right to refuse any membership without having to justify its decision.
- The membership agreement must be signed by the director of the company or a representative with power of attorney

### Membership fees

Application and Annual Membership fees are payable by active members only and are set and reviewed by the Board of Directors. An Application Fee is due upon the admission of a member. Annual Membership fees are payable on January 1<sup>st</sup> of each year. Each fiscal year runs from January 1st to December 31st. The admission of a member during the year entails the payment of Annual Membership fees on a pro rata basis for the remaining months, month of admission included. Members who have not renewed their Membership for one year will have to make a new application and will be charged the Application Fee.

**Membership is per company, according to company registration. In case of a group of companies, application should be per registered company. In case of several offices, including offices in different countries, but without separated company registrations, the application and the number of employees/employers should be for all offices.**

**The number of employees/employers should include the company directors, the number of persons working in the yachting sector (Sales Brokers, Charter brokers, Yacht Manager, Sales Representative, Agents, Independent Agents, etc...) and shared or full-time administrative resources (Assistants, Accountant, Marketing, Human Resources, IT, etc...)**
